### FEBRUARY 3RD

The Sideshow Taskforce took decisive action to address illegal street takeovers, resulting in a major victory for public safety. The operation led to the towing of 89 vehicles, over 250 individuals being interviewed and charged, and the effective elimination of sideshow activity within San Joaquin



### JULY

In partnership with the District Attorney's Office, we co-founded the Multi-Agency Anti-Sexual Assault and Labor Trafficking Task Force (ASALT), a collaborative effort to combat and prevent sexual assault and labor trafficking across the region.







SPECIAL SERVICES DIVISION (SSD) addresses street crimes, quality-of-life issues, and complex incidents while supporting other divisions. Using an Intelligence-Led Policing model, SSD leverages data from the Research and Intelligence Division (RAID) to identify problem areas, groups, and crime trends. Flexible and adaptable, SSD personnel can be reassigned to various operations, pooling resources to quickly tackle complex problems without being constrained by minimum staffing requirements.



The Research and Intelligence Division (RAID), formerly known as Crime Analysis, drives the Intelligence-Led Policing model by collecting and analyzing data to inform resource deployment and investigations. RAID's functions include subject and location workups, crime predictions, tactical forecasting, cellular forensics, social media analysis, and crime trend statistics. Their insights allow personnel to adjust schedules and strategies to address emerging issues effectively.
