## **CCW Non-Resident Live-Fire Requirements**

Non-resident Applicants must complete a live-fire shooting exercise as required by California Penal Code section 26165, subdivision (a)(6), for each handgun they intend to carry concealed upon their person in California.

- All live-fire certificates MUST include the following for each weapon:
  - 1. Make, Model, Caliber, and Serial Number

It is the Nonresident Applicant's Responsibility to follow all California Concealed Carry Firearms laws to include Carrying Concealed Firearms Lawful in California.

- California licensing authorities may request photos of the firearm(s) to ensure that they may be lawfully carried in California (e.g. not an assault weapon under California Penal Code sections 30510, 30515).
- Possession of large-capacity magazines, defined as ammunition -feeding devices capable of holding more than 10 round is generally prohibited under California Penal Code section 32310, however, if a magazine has been permanently modified to accept not more than 10 rounds, it is not considered a large capacity magazine and is therefore legal to possess.
- San Joaquin County Sheriff CCW Permits allows a maximum of three (3) weapons to be listed on their CCW Permits.

## Course of Live-Fire for each weapon listed on Application:

The live-fire portion of the training shall be demonstrated with all weapons to be listed on the license. The target shall measure 12 X 16 inches and must be capable of being scored. Applicants are to have a minimum passing score of %80.

## **REQUIRMENT FOR RANGE INSTRUCTORS:**

- Per United States District Court Central District of California Case No 2:23-cv\_10169-SPG (ADSx) Qualifications required for CCW Instructors:
  - 1. BSIS, Dept of Consumer Affairs, State of California- Firearm Instructor
  - 2. POST (State of California) Firearm Instructor, Rangemaster, or Concealed Carry Tactics Instructor
  - 3. CHP or CDCR- Firearm Instructor, Weapons Instructor, or Rangemaster
  - 4. NRA-LE Instructor, or NRA Basics of Personal Protection Outside the Home Instructor
    - Must additionally be NRA Certified Pistol Instructor and Personal Protection of the Home Instructor
